AUGUST 1997 – The Virginia Department of Transportation has announced that the Town of Vienna's application for the "Streetscape Connection Project" was accepted into the Transportation Enhancement Program and allocated \$120,000. The money will be used to reimburse the Town for the construction of brick sidewalks connecting Maple Avenue and Church Street.

AUGUST 1987 – The Vienna Centennial Committee gratefully acknowledges receipt of its first donation from a community organization, the Vienna Chapter of the American Association of Retired Persons. The Centennial Committee has also received a generous pledge from the Board of Directors of Vienna Youth, Inc., for a donation each year until 1990.

AUGUST 1977 – Town Manager C. Clay Harrell is urging the passage of legislation in the Virginia General Assembly to allow local governments to declare local water emergencies. The Occoquan Reservoir is at its lowest levels ever and although Vienna does not receive water from Occoquan, the Town plans to cooperate with areas that do by enforcing its water conservation ordinance if necessary.

AUGUST 1967 – Addressing the commuter traffic of 40 years ago, Mayor Jim Martinelli wrote, "Too often, in our haste to reach our destinations, we lose sight of the rights of others on the road to enter, exit, or cross the lane of traffic. Let us all determine in our driving to make Vienna 'Our Kind of Town' for everyone."

Yard Sale Reminder

Each household in town may hold two yard sales per year. No permit is required. Two advertising signs, no larger than four square feet each, may be displayed on the property where the sale takes place, and four directional signs, no larger than two square feet each, may be placed on other private property with the owner's permission. Signs may not be exhibited more than two days prior to the start of the sale. Signs are not permitted on public property, in the public right-of-way (10 feet from the curb or edge of pavement) or on utility poles. Illegally placed signs will be removed. Message from the Mayor

The entire Vienna community was shaken by the disastrous ending to our fireworks display on July 4th. I have personally been in touch with the families of everyone injured in the accident and ask that we all continue to keep them in our thoughts and prayers.

The highest commendations must go to Fire and Rescue Personnel, Vienna Police Officers, Vienna Parks and Recreation Staff, Fairfax County Police helicopter crew, and representatives of the Fairfax County Fire Marshal's Office who responded professionally and compassionately to the chaotic scene of the accident, and sincere appreciation to the "Good Samaritans" among the crowd who assisted them.

The Fire Marshal's investigators have determined that the mishap was accidental, a "catastrophic failure" of a 25-round, three-inch mortar that launched into the crowd at a low trajectory. As you may have heard or read in news reports, several similar incidents occurred at fireworks displays throughout the county; fortunately, no other injuries were reported.

In the weeks and months ahead, the Town Council will be reviewing our July 4th fireworks program with the Fire Marshal's Office and studying all options concerning its future. We welcome your comments.

Vehicle Decals No Longer Required as of April 15, 2008

The Town Council has eliminated Vienna's motor vehicle license tax beginning next April 15, and residents will no longer be required to display Vienna decals inside their windshields. Until then, however, vehicles must continue to display the 2007 decals, and a decal must be purchased for any new vehicle.

Decals may be obtained by mail or in person at Town Hall. Call the Finance Department at 703-255-6323 for information. Registration forms may be downloaded from the Town's Web site, *www.viennava.gov*. Decals cost \$20 for passenger cars and trucks under 4,000 pounds, \$25 for cars and trucks 4,000 pounds and over, and \$10.50 for motorcycles. The vehicle license tax is reduced by one-half from October 1 to January 15 and by two-thirds from January 16 to April 1. A decal may be transferred to another vehicle by the same owner for \$1 by returning the original decal, or a substantial part of the decal, along with the registration form and the \$1 transfer fee.

Town of Vienna residents must continue to pay Fairfax County personal property tax on motor vehicles. For information about personal property tax, call the County Office of Assessments at 703-222-8234 or visit the County Web site, www.fairfaxcounty.gov.

Free Wi-Fi Connection at Town Green



The Town of Vienna is providing free wireless Internet access at the Town Green, located at Maple Avenue and Mill Street.

This is a pilot project to attract more customers to downtown Vienna, encourage the use of this new public park, and enable more citizens to access Town services online.

From dawn to dusk throughout the year, users can log in using "Vienna Gov't Sponsored Free WiFi" for the SSID. (SSID stands for "Service Set Identifier" and is a unique ID for naming a wireless network. All wireless devices attempting to communicate with each other must share the same SSID.)

Be a Friend of the Vienna Town Green

In the Washington metropolitan area we are fortunate to have convenient access to cultural arts centers like Wolf Trap and the Kennedy Center. Now we have free performing arts in our own local community. And area residents have a fun and exciting way to volunteer by joining the **Friends of the Vienna Town Green**.

The first season of the **Summer on the Green** concert series is already a rousing success. It is so pleasant to enjoy a
concert outdoors, whether in the evening
or at noontime. If you want to eat during
the performance, there are many places
where a carryout meal may be purchased,
or you can bring your own picnic from
home.

Performers were booked by the Department of Parks and Recreation, but there was an opportunity to involve corporations, citizen organizations and individuals as sponsors of the shows. This first year, sponsors were recruited to pay for each show individually. In the future, a more general fundraising program is needed to increase the number of performances. A cadre of volunteers is also needed.

And so the **Friends of the Vienna Town Green** was founded. The Friends will not only raise funds and recruit sponsors for the concert series, they will help with the shows themselves. They will sup-

plement the Town staff by learning to help the performers set up and take down the sound system and other equipment, and by attending shows and ensuring that each show goes on as scheduled.

We are following in the footsteps of other Friends organizations for local parks. For example, lack of County money for a weed whacker was the impetus behind the founding of the Friends of Mason District Park in 1980. Mason's Friends started a concert series in 1990, which now features concerts three evenings each week, plus children's shows on Saturdays. Cofounder Penelope Gross, now Mason District Supervisor, says that the Friends of Mason District Park have raised more than \$150,000 over the years for the park and its programs. "The Friends take a personal interest in the park and support the staff in park use and programs for the benefit of the community," said Gross.

Several Vienna-area residents have already volunteered to be a part of the Friends of the Vienna Town Green, and they welcome others to join them. The Department of Parks and Recreation plans to conduct training sessions for the Friends at shows in September. (Not only has the audience enjoyed it, word of the Town Green has spread and more performers are asking to play, so a September series will be added to the calendar.)


Enjoy Our Parks This Summer

FY 2007-08 Budget Adopted

The Town's adopted budget for fiscal year 2007-08, which began July 1, totals \$29,090,210 for all funds, an increase of \$1,038,898 or 3.7% over last year.

The budget is based on a real estate tax rate of 19.96 ¢ per \$100 of assessed valuation, an increase of 1.34 ¢ from last year's tax rate. Of that increase, 62 ¢ is the amount necessary to recoup a portion of the revenue lost as a result of the Town Council's decision to eliminate the vehicle license tax. The additional shortfall will be made up from an increase in the cigarette tax from 50 ¢ to 75 ¢ per pack.

In the Water and Sewer Fund, the water rate for town residents has increased from \$3.44 to \$3.99 per 1,000 gallons and the sewer rate from \$4.54 to \$4.77 per 1,000 gallons. This increase is necessary to protect the Town's bond rating, which could be adversely affected by continuing to use water and sewer fund balances to support the rising costs of purchasing water and sewage treatment. Overall, a town resident will pay an additional \$59.28 per year for water and sewer service based on a quarterly average usage of 19,000 gallons. This represents an increase of 9.77% over existing rates.

"Project Lifesaver" Brings Loved Ones Home Safely

Project Lifesaver, sponsored by the Fairfax County Sheriff's Office, is a program that assists individuals with Alzheimer's disease, Down syndrome, autism, and related diseases and disabilities. Using state-of-the-art technology and a specially trained search and rescue team, the program locates wandering adults and children and returns them to their families and caregivers.

Project Lifesaver clients wear a personalized wristband that emits a silent tracking signal every second, 24 hours a day. The signal can be tracked on the ground or from the air over several miles. Since each wristband has a unique frequency, the Project Lifesaver search team can quickly locate a person who has wandered away from home.

The Project Lifesaver team comprises approximately 145 volunteers from within the Sheriff's Office, both sworn deputies and civilian staff members, who are trained and certified in electronic search and rescue. The technology used has reduced search times from hours and days to minutes. In over 1,450 searches nationwide, there have been no reported serious injuries or deaths, and recoveries average less than 30 minutes.

To enter someone in the Project Lifesaver program, the following requirements must be met:

- 1. The client must be a resident of Fairfax County, Fairfax City, or the Towns of Vienna or Herndon.
- 2. The client must have a legally responsible caregiver willing to place the client in the program.
- 3. Clients and caregivers must abide by the conditions of the program and contract.
 4. Complete the application process.

Vegetation Must Be Kept Trimmed

The Town Code specifies that "owners of property within the Town shall not allow grass, weeds and other foreign objects to exceed 6 inches in height within 100 feet of any street or adjacent property line."

Property owners found in violation of this ordinance will be sent a certified letter from the Department of Planning and Zoning giving them 10 days to cut their grass. If they do not, the Town will cut the grass and bill the property owners. Unpaid bills will be recorded as tax liens against offending properties.

The Town Code also restricts the height of bushes, hedges, and other plantings (and fences) to three feet above the curb level within 25 feet of an intersection. Keeping foliage trimmed makes it easier for pedestrians and bicyclists to see approaching vehicles.

Every resident's effort to keep plantings trimmed will help make Vienna a safer and more attractive community, and all the walkers and bicyclists in your neighborhood will appreciate it! For more information, or to report violations, call the Department of Planning and Zoning at 703-255-6341.

PLEASE NOTE: Before cutting any tree, shrub or other plant near your home, first make sure it belongs to you. If you are unsure whether vegetation is on your property or in the public right-of-way, check with the Parks and Recreation Department, 703-255-6360.

Grass and weeds growing up through cracks in the sidewalk and between the sidewalk and street detract from Vienna's beauty. The Town government simply does not have the personnel required to maintain these rights-of-way as it would like, and so asks residents to assist by controlling grass and weeds next to their property.
